### **Healthcare Staffing Market Analysis**

Industry leaders continue robust M&A activity

#### Overview

The \$14 billion U.S. healthcare staffing and physician outsourcing industry is expected to continue growing due to increased demand for outsourced recruitment services and the need to cut healthcare expenditures. M&A activity in this industry has continued to grow as the economic recovery progresses.

Revenue multiples in the public markets are currently tracking at a median of 0.8x, while EBITDA multiples have a median of 11.5x. Since the end of 2012, these have grown 60% and 13% respectively.

Transaction multiples are tracking in a slightly lower range, with median revenue multiples of 0.6x and median EBITDA multiples of 9.0x over the past two years. While the market underperformed the S&P index from late 2011 to mid 2012, recent regulatory pressures for hospitals to cut costs have renewed industry growth, which has been reflected in public market valuations.

### **Trends**

The U.S. healthcare staffing and physician outsourcing industry is highly fragmented, consisting mainly of small businesses servicing local healthcare facilities. The top four players combined only account for approximately 20% of market share. As such, healthcare staffing companies continue to consolidate through M&A activity. IPC The Hospitalist acquired the assets of at least 13 hospitalist physician practices in 2013. Similarly, Team Health views acquisitions as the largest component of its net revenue growth, contributing 12.9% of the 20.3% net revenue

increase in the first quarter of 2012.

At the same time some large players are also using acquisitions as a means to expand their geographic reach. On Assignment, IPC The Hospitalist, and Epic Health have all acknowledged geographic growth as an important strategy in recent press releases. In 2012 and 2013, IPC has diversified its geographic coverage into states such as New York and Kansas while continuing to strengthen its presence in existing markets such as Florida and New Jersey. Epic Health Services has also been expanding its geographic exposure by specifically looking towards the Northeastern U.S. region.

Companies have also been seeking acquisitions to grow specific segments of their businesses and increase service offerings. For example, in 2012 and 2013, Team Health acquired multiple businesses that provide emergency department staffing and hospitalist staffing services in a number of states. These acquisitions expanded its presence in anesthesia and urgent care, and have provided an entrance into the inpatient specialty care market. On Assignment has also stated that it will continue expanding its permanent placement capabilities among other service offerings.

AMN Healthcare, the largest healthcare staffing company, stated that it seeks to improve efficiency through expansion of services. AMN's acquisition of ShiftWise in November 2013 complements its current workforce solutions offerings.

Internationally, M&A activity include Interim Healthcare's acquisition of Bluebird in the U.K. as well as Helios' acquisition of Techno in Japan.
