Pharma Business Services Market Analysis


Outsourced service providers to the pharmaceutical and medical device industry continue to expand their service offerings and geographic presence—and CROs have become buyers

Industry Multiples and Index

Valuations in the space continue to rise, with revenue multiples in the public markets currently tracking at a median of 2.7x, and median EBITDA multiples of 15.4x.

Median revenue multiples are 1.7x and median EBITDA multiples are 13.9x for transactions over the past three years. In September 2015 transaction multiples of EBITDA were 9.3x, so valuations have moved significantly higher.

Brocair's index of pharma business services companies outperformed the S&P 500, and is up approximately 135% in the past five years, versus nearly 100% for the broader index.

Trends

M&A activity in the space has continued apace as industry leaders have been trying to consolidate the market share by merging with competitors, and traditional CROs have been moving into complementary services in the space.

In November 2016, Advent and Thomas H. Lee bought inVentiv for \$3.8 billion; six months later, in May 2017, INC Research and inVentiv announced a 53/47 merger to form the second largest biopharmaceutical outsourcing provider with an enterprise value of \$7.4 billion. In October 2016, Quintiles merged with IMS Health in a \$13.2 billion transaction that combined IMS Health's global information solutions with Quintiles' product development services.

Tough regulatory scrutiny has continued, encouraging deals in outsourced regulatory and compliance services. The December 2016 acquisition by Model N of Revitas in the U.S. and the October 2016 purchase of Sofus Regulatory Affairs by Xendo in Europe are recent examples.


The global pharmacovigilance software market is expected to grow at a CAGR of 6.2% from 2016-2020, and is expected to reach a value of \$207.3 million in 2024.¹ North America accounts for the largest share of the drug safety software market, followed by Europe.

UDG Healthcare has continued to add to its Ashfield medical communications business. Six months after its acquisition of the second largest U.K. healthcare consultancy firm Pegasus in April 2016, UDG acquired STEM Marketing to further enhance its commercial, clinical and communications services. In May 2017, UDG closed the acquisition of five marketing services companies including Germany-based Sellxpert and four Spanish companies, to augment its presence and capabilities in Europe. ¹GosReports, ReportLinker
