Healthcare Staffing Market Analysis


M&A activity in this industry has continued to grow as market leaders seek to consolidate this highly fragmented industry.


Industry Multiples and Index

Revenue multiples in the public markets are currently tracking at a median of 1.2x, while EBITDA multiples have a median of 13.7x.

Transaction multiples are tracking in a higher range, with median revenue multiples of 2.0x and median EBITDA multiples of 19.8x over the past two years.

Brocair's index of healthcare staffing companies has outperformed the S&P 500 index since 2011. In the last 6 months, the index reached a 10-year high. Share prices have been pushed higher due to increased M&A activity in the space, with two large companies having received takeover offers in the last 3 months.





Trends

M&A activity in the space has been robust as a result of the consolidation among larger players in the healthcare staffing industry. Market leaders have also been active in consolidating the highly fragmented industry that consists mainly of small businesses servicing local healthcare facilities.

After the announced acquisition of IPC Healthcare in August 2015 by Team Health to form an industry leader in the hospital and post-acute markets, AmSurg Corp then announced the proposed acquisition of Team Health to create an even larger entity within the healthcare staffing industry in October 2015. MEDNAX has also made numerous acquisitions in the healthcare staffing industry, including a May 2015 acquisition of Virtual Radiologic Corporation to broaden its presence in the teleradiology space.

Companies have also been seeking acquisitions to expand service offerings and geographic coverage. In September 2015, AMN Healthcare Service acquired The First String Healthcare, Inc. to increase its recruiting service capabilities; In August 2015, Schumacher Group acquired Hospital Physician Partners to increase its coverage in 29 states and 358 hospitals in the U.S.


Overall healthcare expenditures are expected to grow at an annualized rate of 5.8% from 2014 to 2024. ¹ This is a key driver in the strength of the healthcare staffing industry, which is currently being fueled by U.S. regulatory changes. To capitalize on this growth, there has been increased acquisition activity among financial sponsors. In May 2015, Clearview Capital acquired Advanced Medical Personnel Services, a provider of therapy staffing solutions; In December 2014, Sovereign Capital Partners identified an opportunity presented by the increasing elderly population in the U.K through the acquisition of Nurse Plus & Carer Plus, a specialist in recruitment services for nursing homes and assisted care facilities.
